# THE UNITED METHODIST DENOMINATION

What has happened? What is happening? What will happen?

#### General Conference 2016

- Call for Bishops to lead the denomination with a plan on human sexuality and the UMC
- Result = Way Forward task force and a called General Conference

- Special Called General Conference February 2019
  - Considered 3 Plans (Traditional, One Church Plan, Connectional Conference Plan)
  - Traditional Plan approved with a 438-384 vote (412 required = 26 votes)
  - An Exit Plan was passed for churches to leave the denomination (complicated process in UMC)
  - Called into question some of the legality of the legislation approved

#### Judicial Council review

- April 2019 the Judicial Council ruled some of the legislation unconstitutional
- The JC upheld the following changes to the Book of Discipline:
  - Broadening of the definition of "self-avowed practicing homosexual"
  - 2. Just Resolution for how complaints are processed was amended

- Judicial Council review cont'd
  - 3. Bishops cannot consecrate a Bishop or ordain a clergy candidate who are self avowed homosexuals
  - 4. Clergy performing same sex wedding will be suspended on first offense without pay and second offense leads to surrender of credentials
  - 5. They upheld the exit plan as long as the exit is because of disagreement with the Traditional Plan legislation

- Annual Conferences Summer 2019 in the US
  - Majority of the General Conferences (80%) voted for majority centrist/progressive delegations.
  - 52% of Annual Conferences in the US approved legislation resisting the Traditional Plan



# WHAT IS HAPPENING NOW?

- Preparing for regularly scheduled General Conference May 2020
- Deadline for petitions is September 18, 2019
- Conversations happening at a high level negotiating possible plans forward
- Delegations are preparing to receive and review hundreds of pieces of legislation – most of which will have nothing to do with LGBTQ+ issues

# WHAT MAY HAPPEN?

- We don't know yet
- Here's what we do know:
  - WCA (Wesley Covenant Association) invited churches to join their Association and prepare to leave the denomination all at the same time
  - Work happening within denomination to explore legislation that will recommend changing geographical organization and allow Jurisdictions to decide about LGBTQ rather than the global denomination making decisions for the US.

### WHAT MAY HAPPEN?

- Conversations are happening about the possible dissolution of the denomination and creating 2 new denominations – Called the Indianapolis Plan (not being well received)
- Where we are now is not sustainable so something different will be decided in May
